manuscript is written with a line density of 1.5 spaces, Times New Roman with 12-pt font.



### THANK YOU [Font Times New Roman, Size: 12, bold]

Contain acknowledgments to the funder institution and or individuals who have helped implement research and authoring manuscript. It is tentative [Font: Times New Roman, size: 12, regular].

## BIBLIOGRAPHY [Times New Roman 12, bold]

General guidelines for writing a reference:

References listed in the bibliography are only references quoted in the manuscript.

For article research results, the bibliography is at least 15, and it has referred to from about 20% of book text and 80% scientific journal's article.

- The updated scientific journals need to be considered, at least is the results of relevant publications in the last ten years.
- The bibliography is arranged alphabetically based on the alphabetical form of the author's name.
- Author's name stipulation: the name displayed is the last name (surname) followed by the abbreviation of the first name (and middle, if any).
- If there is more than one author, then the writing is the same and, if there are two or more people, the word uses the '&' symbol.
- The reference title begins with a capital letter in each syllable, except for conjunctions.
- Every writing, the name, (year), article title and, so on ends with a period (.) before continuing with the next word. For writing volume (number), journals are marked with a colon (:) without any spaces.
- Writing bibliography and citations are recommended using a reference application (Mendeley) or a bibliography with Harvard-APA Style. [Font: Times New Roman, size: 10, regular.]
- Examples of authoring can be seen in explaining each type of literature worth mentioning. If the source of bibliography is an article in a scientific journal, it is written in the order: the name of the author. (year). the title of the article. *Journal name*. Volume (number): page (Italicized journal name). If the author is more than one, the writing name is the same and the name of the last author uses '&'.

- If the bibliography source is from a textbook, it is written in the author's name. (year). The name of the book. Volume. Edition. Page and, proceeding publisher (the title article is in italic).

- If the bibliography source is an article in proceedings, it is written in the following order: author's name. (year). Seminar script title. The title of the proceedings. The Seminars Venue. Volume, Edition, Pages, and publisher of proceedings).

- If the bibliography source is an article in an unpublished scientific work (e.g., thesis, dissertations, and research reports), it is the author's name. (year). Research report title. Research project name. Publishing agency/institution (Writing of thesis/dissertation/research report in italics).

- If the bibliography source is an article in a general newspaper/magazine is written in the following order: author's name. (year). Article title. The name of the newspaper/magazine. City, date of publication, and the page (the title article is italic).
